- gemstones or precious metals
- jewellery that includes gemstones or precious metals
- watches
- sporting or recreational goods (not clothing or footwear)
- watercraft (including jet skis, windsurfers, surfboards) or parts of watercraft
- musical instruments (not pianos other than electric or electronic)
- portable engine-powered, motorised or air-powered tools or equipment
- tool kits
- photographic equipment or video cameras
- computer programs or computer programs and data, including those comprising games for use with interactive game consoles;
- electronic or electronic goods e.g. televisions, radios, CD players or other audio/visual systems mobile or portable telephones, microwave ovens, (not including refrigerators, washing machines, clothes dryers, dishwashers, stoves & under bench ovens or wall ovens)
- compact discs
- vehicles without automotive power (e.g. pushbikes, caravans or trailers)
- motor vehicles
