

RECOGNITION OF PRIOR LEARNING

**Are you able to do the tasks of a qualified automotive technician?
Do you want or need to be recognised for the expertise and value you bring to your
workplace and automotive industry?**

Through a 3 Step process the MTA's RTO Accredited Recognition of Prior Learning (RPL) program supports automotive tradespeople to have their skills, knowledge, education, training and experience assessed, enabling formal qualifications to be granted.

MTA's RPL process will assess your skills and knowledge (gained both formally and/or informally) towards attaining units of competency in any of the following qualifications:

- ▶ **AUR20218** Certificate II in Automotive Air Conditioning Technology
- ▶ **AUR31016** Certificate III in Automotive Sales
- ▶ **AUR30416** Certificate III in Agricultural Mechanical Technology
- ▶ **AUR31216** Certificate III In Mobile Plant Technology
- ▶ **AUR31816** Certificate III in Heavy Commercial Trailer Technology
- ▶ **AUR30316** Certificate III in Automotive Electrical Technology
- ▶ **AUR30616** Certificate III in Light Vehicle Mechanical Technology
- ▶ **AUR31116** Certificate III in Heavy Commercial Vehicle Mechanical Technology
- ▶ **AUR32116** Certificate III in Automotive Body Repair Technology
- ▶ **AUR32416** Certificate III in Automotive Refinishing Technology

3 STEPS to RPL

To discuss the requirements and process of gaining Recognition of Prior Learning, please contact the MTA by calling 8241 0522 or email adminroyalpark@mtaofsa.com.au to speak with an Assessor.

If you are eligible for assessment, there are three steps involved.

STEP 1 - Application (\$220.00)

The application process involves an initial interview, advice and/or assistance in regards to additional evidence which may be required and determination as to whether RPL or gap training is appropriate for you.

If the Assessor determines that the evidence provided and subsequent additional evidence is sufficient, you will go onto Step 2 to gain assessment of each individual unit.

STEP 2 - Assessment (\$150.00 per unit - up to 36 units)

The Assessment is based on the units in the Qualifications listed above in addition to a self-assessment guide, RPL assessment, evidence assessments (incl. practical demonstration and contacting employers) and one re-evaluation.

STEP 3 - Outcome

On finishing an assessment (or number of assessments), the MTA will provide you with one of the following outcomes:

- ▶ A full qualification.
- ▶ A Statement of Attainment for the units you have been assessed as competent for and that do not equal a full qualification. These may be used as credit toward gaining a full qualification
- ▶ An identified gap or bridging training plan. The MTA will assist in delivering this further training (additional charges apply).
- ▶ Notification that the evidence provided does not align sufficiently with the course requirements resulting in no formal recognition by the Assessor.
